

**Traffic Safety:**

- Heed to signals of Vending Park control staff.
- Always yield to the right-of-way of pedestrians.
- Follow all one-way traffic patterns.

**Injuries:** The Township provides reasonable care and protection to the property, people and premises. The Township however, is not responsible for injuries caused by others or injuries to persons entering the premises.

**Damages:** The Township is not responsible for damages or loss due to fire, theft, breakages or collision. Leaving articles in a vehicle is done at the risk of the owner.

# RULES & REGULATIONS

**Hours:** The park is open daily from 6 am to 7 pm.

**Vending Spaces:** The park can facilitate seven (7) vendors, allotting each approx. 20' of space. Use of the spaces are on a first come first serve basis. No vendor shall reserve or hold a space for another vendor.

**Use of Space:** No vendor shall use their space so as to interfere with an adjacent vendor or jeopardize the health and safety of others.

Vendors are expected to conduct business between themselves and the public in a professional manner.

**Parking:** All vendors must park their vehicles in designated areas. Any vendor parking outside those areas will have their Vending Park privileges suspended.

**Proper I.D.:** All vendors must possess a valid Veteran's I.D. and a Cumberland County Peddler's License. These documents must be carried with you and presented upon request by any enforcement agent.

**Refunds:** Vendors agree to make a satisfactory exchange or refund to a customer, unless an acceptable return policy is posted in their space.

**Displays:** No overhead metal pipe racks are allowed to be used in the park unless prior approval is received from Maurice River Township.

The manner in which items are displayed is subject to revision or elimination at the discretion of the Township.

**Noise:** Vendors must regulate the volume of radios, sound equipment, etc. so as not to interfere with other vendors.

No material which may be construed as offensive may be broadcast; loud noise and foul and abusive language will not be tolerated.

**Condition:** Each vendor must leave their vending space in the same condition that it was found upon their arrival.

**Trash:** All trash is to be put in the receptacles provided. All boxes, cartons or unsold merchandise must be taken with each vendor upon leaving the Vending Park.

---

**THE FOLLOWING ITEMS ARE NOT PERMITTED TO BE SOLD IN THE VENDING PARK:** explosives, firearms, ammunition, flammables, dangerous items, items of obscene or pornographic nature, alcoholic beverages, drugs or drug paraphernalia, illegal/counterfeit/stolen items.

The Township reserves the right to inspect all items proposed to be sold and to eliminate any items from sale that, in the opinion of the Township, are offensive.
